**Increased Traffic Enforcement Planned  
For Manhasset Villages**

May 2, 2017 - After a series of meetings and conversations over the past two weeks, NCPD Commissioner Thomas Krumpter and Third Precinct Commander Dan Flanagan have agreed to a program of increased enforcement of traffic violations in the Manhasset villages starting shortly and continuing for a period of time based on target areas identified by the Villages. Speeding and stop sign violations will be a focus and target areas include "cut through" streets and this may include Webster Avenue and Plandome Road (perhaps others) in Plandome Heights. Increased enforcement is expected to begin at any time and continue for an indefinite period.

When the police target traffic enforcement in our "neighborhoods," the targets often end up being our "neighbors." So it may be helpful to give thoughtful consideration to my your own habits and to take extra care to observe speed limits and stop signs. This is particularly important now that the children are outside more. The best outcome would not be more tickets, but a safer community with fewer speeding and stop sign infractions. That is the goal.

In addition to traffic we have requested additional NCPD monitoring of the Plandome Heights Preserve and Plandome Pond Park for occurrences of "youth mischief" and we have requested more neighborhood patrols.

Beyond these items, Commissioner Krumpter spoke to us about crime statistics and police resources both moving in a positive direction.
