I write to advise you of a matter related to our shared interest in Plandome Road in the Village of Plandome Heights.

I have today authorized the upgrade of the Street Lights on that 1,900 linear feet of Plandome Road with the purchase of new LED lighting. The new lighting will be "Cobra head" General Electric light fixtures, affixed to six-foot aluminum arms extending from the utility poles. The new lighting will be bright white, focused "down lighting" and will be similar to the lighting in the contiguous part of the road north of our Village in Plandome.

The new lighting will replace existing yellow light fixtures that currently distribute the light laterally. Our Trustees believe that the new lighting will be a significant improvement in public safety over the prior lighting on this heavily traveled road.

We own the lighting on that section of Plandome Road. However, since the road is owned by Nassau County, the County has jurisdiction to approve any change. As such, we appreciate Executive Curran's office expediting approval of our plan, at our cost, to improve the lighting.

Our Village is happy to make this investment in public safety. That road that is used by 19,000 residents, mostly Town and County, each day. It will take some weeks for our contractor, Welsbach, to procure the materials and perform the work. I thought it appropriate to share this development with you since we have shared interest in that road.
