A Special Meeting of the Board of Trustees was called to order by the Mayor at 10:01 a.m. on Friday, March 26, 2021, via video conference, pursuant to Executive Orders relating to the COVID-19 pandemic, issued by Governor Cuomo impacting the NYS Open Meetings Law. The meeting was recorded for later transcription.

Mayor Riscica opened the meeting, welcomed the residents and gave opening remarks about the potential purchase of a village home for use of a village hall.
