Executive Mangano -

I write to seek your help with a matter that is distressing to our mutual constituents.

Plandome Road in Manhasset is in a poor state of repair and needs to be replaced. The Town of North Hempstead plans to do that replacement, from Northern Boulevard to the edge of the Village of Plandome Heights, this Spring. The project stops at the Village line because Nassau County is responsible for repair of the 0.3 mile stretch of Plandome Road that is in our Village. As you know, Plandome Road is a busy thoroughfare on the west edge of the Port Washington Peninsula used by many residents in both Manhasset and Port Washington.

The residents of our Village are upset that this road project will stop 0.3 miles short of what is needed. They call me and ask me why....they call the Town. As you can imagine, we don't want to tell the residents that "Nassau County won't fix this tiny stretch of road" when the rest of the road is being done.

To me, it makes sense to extend this road project the last 0.3 mile to complete the repair when all the equipment, manpower and materials will already be deployed. I understand budget dollars are tight, and I appreciate all the work you and the Legislature do to stretch our tax dollars. However, it seems that we should be able to find funds to help with this tiny project so that the whole job here would be done.
