Dear Dina and Anna:

We write about a concern over two Town roads in which we share an interest. Both roads are heavily trafficked, well worn, frequently patched with repairs that don't last and suffered over this harsh winter. One road is scheduled for work in 2016; one is not scheduled at all.

We request your help in getting a higher priority placed on a more permanent repair of these two roads. They are:

- Webster Avenue, through the bridge over the railroad tracks This is a Town road that is in the Village of Plandome Heights (LD 6) on one side and in unincorporated Manhasset (LD 4) on the other. This is a busy road that is used for alternate east/west access to Plandome Road particularly by those (a) exiting Flower Hill or (b) from other parts of Manhasset wishing to bypass downtown Manhasset. The road has been in general disrepair for several years and, to its credit, the Highway Department regularly patches potholes. Because of the high traffic, the pothole repairs rarely last.
- Orchard Street/Maple Place This is the road that rings the commercial area behind Rite Aid (LD 4) serving many commercial establishments including The Village of Plandome Heights (LD 6), Chase Bank, USPO, Dunkin Donuts, Silva Realty, Manhasset Florist, etc. It is heavily traveled and it is in terrible shape. Again, frequent repairs simple open up in short order. Scheduled for repair in 2016, the harsh winter makes a sooner repair desirable/necessary.

These matters are important to the constituents we all serve and so we will appreciate every effort you can make to raise the level of priority given to these two Town roads.
