**Supervisor DeSena Swears in New Plandome Heights Trustees Mary Hauck, Kristina Lobosco and Florence Musalo at 2022 Annual Meeting**

**April 4, 2022** – On April 4, 2022, the Incorporated Village of Plandome Heights held its annual meeting at Village Hall located at 37 Orchard Street in Manhasset.

Supervisor Jennifer DeSena met with Mayor Kenneth C. Riscica and the Village Trustees to discuss Village and Town interests and opportunities. Following this, Supervisor DeSena officiated in swearing in Mayor Riscica and then swearing in the three newly elected Trustees, Mary Hauck, Kristina Lobosco and Florence Musalo.

Following the swearing in, Mayor Riscica gave a presentation “2021 – 22 - Year in Review; A Year of Great Accomplishments” highlighting the major accomplishments from the past fiscal year. Supervisor DeSena stayed to hear the presentation. Accomplishments include consolidating the functions of the Planning Board into the Board of Trustees, newly installed LED lights throughout the Village, efforts that raised hundreds of thousands of dollars in grant money for infrastructure, and significant progress from the digital records committee. Most notably however, is the “New Starting Line” plan that is expected to be completed by summer of 2022. It will result in significant improvements throughout the village, including various gas main work, fire hydrant replacements, new curbs and swales, and curb to curb paving of over 85% of paved roads.

Following this, Mayor Riscica presented his analysis and review of the Village planning process in arriving at Tentative Budget including important “benchmarking” information on our key costs. Our planning process identifies Occupancy, Inflation, Human Resources and Technology as key items of focus. Following that, the Village conducted a Public Hearing on the Tentative Budget and then made various annual appointments, approved various annual contracts and conducted other Village business.
