As discussed at our December 2, 2024 meeting, this meeting was convened to further consider and finalize the remaining spending of The Coronavirus State and Local Fiscal Recovery Funds (SLFRF) program authorized by the American Rescue Plan Act ("ARPA").

The mayor reviewed (a) ARPA reimbursements and payments previously approved in the December Abstract of Claims Number 7 and (b) proposed additional ARPA spending in December at that time.

The mayor then noted that the additional ARPA spending had been refined with various follow up activity and the remaining December payments to be made were re-summarized for the current facts and understandings. The Mayor noted that certain items remain open (such as some amounts were still being negotiated and the equipment necessary for one service is in the shop and unavailable), but the current list is largely final and committed for expenditures to be made (or committed) before the program deadline of December 31. These proposals were designed to maximize the effective use of remaining ARPA funds.

After discussion, upon motion by Trustee Lobosco, seconded by Trustee Hauck, the following resolution was unanimously adopted by all Trustees present:

RESOLVED, that the Coronavirus State and Local Fiscal Recovery Funds (SLFRF) program authorized by the American Rescue Plan Act. expenditures, has been reviewed and approved by the Trustees, and is hereby accepted, subject to ARPA reimbursements and payments to be decided.

The meeting was adjourned at 2:00 p.m.
